#### CALL TO ORDER:

PUBLIC COMMENT: Angela Barnaby on behalf of Joanna Jackson and Faculty Association

I am speaking for Joanna Jackson, our FA President, who is not able to be here tonight because she is celebrating her granddaughter's birthday. She has asked that I share these thoughts that recognize the contributions of three faculty members who will be retiring at the end of this semester.

#### Chris Drennan

Chris has been an important part of our History department for the past twenty years, teaching and developing courses to expand what CCC offers. In his position, he took several trips to China to recruit students, and served as a liaison with the SUNY China 150 program, which saw CCC host 12 students from the affected earthquake area in Sichuan province.

With two colleagues, Chris helped to establish the Center for Governance at CCC, which has since held various events, including a series on Women in Politics and campaign debates for the mayor of Plattsburgh.

Beyond his department, Chris has served for more than 15 years as an advisor to PTK, giving him the opportunity to get to know students beyond the classroom.

I got to know Chris quite well after he accepted the role of Division One Coordinator in Fall 2023. He probably did not know how much he was taking on - the English department can be quite overwhelming – and Chris claims to have worn a path in the hallway carpet as he trekked back and forth between our offices. Despite the heavy workload associated with this position, Chris' unfailing good humor, patience, and willingness to go above and beyond in service to his colleagues made him well-liked and respected. He will be sorely missed.

### Cathy Mitchell

Cathy has been serving the college and the nursing program at CCC since 1992, first as a clinical adjunct in the Nursing department, then as a member of the teaching faculty. Throughout the years, her work educating hundreds of RNs has had a positive impact on our community and beyond.

Cathy's contributions to the Nursing program are extensive. She has drawn on her critical care experience to teach senior nursing students in Medical -Surgical Nursing II and III as well as Pharmacology, coordinating two of the three courses. She helped transition Pharmacology from an elective to a required course in the nursing curriculum. Although she is a soft-hearted and caring person, students have said more than once that they know when she is not happy with them because she gives them "that look" – the "hairy eyeball." One of her students clarified Cathy's passion for student success saying, "when she walks in, I know I will learn!" In addition to serving on numerous committees for the college, Cathy has also served on the EXPLORE conference committee providing Continuing Education Units to local nurses and doctors.

During college breaks, she has worked as a Family Nurse Practitioner in our community pediatric offices, family practice, and in the Emergency Room. She also organized the Medical Brigade trip to Honduras.

Cathy infectious smile will be greatly missed by us all.

### Joanna Jackson

I am very proud to have served here at CCC since 2011. I appreciate all the opportunities I have been given – teaching at Altona Correctional Facility, serving as Faculty Association President, teaching a variety of English courses, and also the American Sign Language class. It makes me so very proud to see these students perform the National Anthem at graduations and basketball games. One of my students even agreed to stand alone – in front of his peers and the spectators – to sign the anthem, and another signed a duet with me at graduation. Our students are truly amazing.

I will miss my students, my colleagues, and this college. But it's time to move on and enjoy the delights of retirement. I wish you well as you move forward into the future in the new location.

- f. Middle states will be visiting April 17-18. When they send a schedule, we will get it out to board members.
- g. Finances Our deficit is less than budgeted, thus far. Unidentified transitional costs are yet to be completely identified.
- h. Move Ken met on the IAM and Plattsburgh MOAs, there is progress but more details to iron out. The Chancellor's visit will be on April 15<sup>th</sup>. More details will be shared when available.
