The Advanced Manufacturing Student Support and Lab Coordinator will set up in-person, hands-on learning and training for Workforce Development and secondary school outreach events, monitor and maintain equipment, and serve as the lab safety coordinator. The individual will support students pursuing workforce training and coursework. The coordinator will be available outside of regular training or class time to provide additional learning opportunities, practice with equipment, as well as refer participants to wraparound services and the next pathway. This is a part-time (approximately 20-29 hours/week), grant-funded 24-month position

Responsibilities:

- Coordinate the scheduling of training and activities with the offices of the Vice President for Academic Affairs and the Center for Community & Workforce Development
- Prepare lab areas for all workforce training and activities
- Provide workforce training students with additional hands-on learning opportunities and assistance outside of class time as needed
- Provide tours of the IAM highlighting workforce training capabilities and educational pathways
- Maintain IAM equipment inventory
- Oversee a preventative maintenance program for equipment, and create maintenance procedures for new equipment
- Assist with installation of and training for new equipment
- Serve as Lab Safety Coordinator
 - Enforce safety policies and procedures
 - Maintain and update policies and procedures
 - o Train and certify students, faculty, and staff on safe operation of equipment
 - Maintain training records

- Inform students of the related educational pathways available (microcredentials, certificates, or degree programs)
- Refer students to wraparound services (advisement, financial aid, etc.).
- Work with faculty as needed in the development of curriculum for microcredentials and training programs in the areas of advanced manufacturing
- Perform other related duties as assigned
- Some evenings and weekends are required
